## SECTION 4) FIRST-AID MEASURES

### Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. Get medical advice/attention if you feel unwell or are concerned.

### Eye Contact

Gently brush product off face. Do not rub eyes. Let the eyes water naturally for a few minutes. Look right and left, then up and down. ## SECTION 5) FIRE-FIGHTING MEASURES

### Suitable Extinguishing Media

Small Fire : Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Large Fire: Dry chemical, CO2, alcohol resistant foam or water spray Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces.

### Unsuitable Extinguishing Media

### Specific Hazards Arising from the Chemical

Dense smoke may be generated while burning.

### Precautions for Firefighters

Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. Water spray is recommended to cool or protect exposed materials or structures. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. ## SECTION 7) HANDLING AND STORAGE

### General

### Ventilation Requirements

### Skin Protection
